ORDER

AUTHORITY

The Arts Council Act (C.C.S.M. c. A140) states:

Membership

2(2) The council shall consist of 15 members to be appointed by the Lieutenant Governor in Council.

Terms of office

3(1) A member of the council shall hold office for a term fixed by the Lieutenant Governor in Council and thereafter until his successor is appointed.

Chairman and vice-chairman

3(2) The Lieutenant Governor in Council shall designate one member as chairman of the council and one member as vice-chairman of the council.

Expenses, etc.

5 The members may be paid reasonable travelling and out-of-pocket expenses incurred by them in the business of the council while away from their ordinary places of residence.
