AUTHORITY

The Public Service Act, C.C.S.M. c. P271, states:

Deputy minister of a department

33(1) Subject to the direction of the department's minister, a deputy minister is responsible for the operation of the department. The deputy minister acts on the minister's behalf.

Appointment by LG in C

33(2) The Lieutenant Governor in Council must appoint and fix the remuneration of a deputy minister.
